Objections / Response to Bihar State Power Transmission Company Limited (BSPTCL). ("Appellants") Appeal No. 383 of 2019 filed before the Hon'ble Appellate Tribunal for Electricity against BERC Tariff Order dated 07.03.2018 in Petition Nos. 37 of 2017 and Order dated 20.11.2018 passed in Review Case No. 15 of 2018.

1. BSPTCL. ("Appellant") has filed Appeal No. 383 of 2019 before the Hon'ble Appellate Tribunal for Electricity challenging the Tariff Order dated 07.03.2018 and order dated 20.11.2018 passed in review case. The above submissions should be supported by an affidavit in the notified format (draft available with Copy of the Appeal at website) and should carry the full name, postal address and e-mail address, if any, of the sender. If the objector wishes to be heard in person, he must appear before the Hon'ble Appellate Tribunal for Electricity at 11:00 am on 16.01.2020 for which no separate notice shall be issued.
