## PUBLIC NOTICE REQUEST FOR COMMENTS / SUGGESTIONS / OBJECTIONS

- Bihar State Power Transmission Company Limited (BSPTCL), transmission licensee, hereby gives notice to all stakeholders and general public that it has filed the Review petition on BERC Tariff Order for True-up for FY 2019-20, Annual Performance Review (APR) for FY 2020-21 and determination of Annual Revenue Requirement (ARR) for FY 2021-22 and Transmission Tariff for FY 2021-22, before the Hon'ble Bihar Electricity Regulatory Commission under BERC (Multi-Year Transmission Tariff and SLDC Charges) Regulations, 2018. The petition has been taken on record by the Hon'ble Commission as Case No. 05 of 2021.
- 2. Abridged form of the Tariff Petition is as indicated below:

## Summary of the Review Tariff Petition

- Employee Expenses allowed in the impugned Order for FY 2019-20 (True-Up), FY 2020-21 (APR) and FY 2021-22 (ARR) under the head, "error apparent on the face of the record" and allow Employee Expenses after considering CPI Inflation on all the base norms as specified in the Regulations and as sought by BSPTCL in this Petition;
- 2. BSPTCL request the Hon'ble Commission to retain the transmission loss of 3.92% for FY 2020-21 and FY 2021-22 as approved in MYT Order dated 15 February 2019;
- 3. Hon'ble Commission is requested to provide relaxation in timelines for submission of various directive as specified in the Tariff Orders as mentioned in this Petition;
- 4. Hon'ble Commission is requested to exempt BSPTCL from New Directive No. 7.3(iii) in Tariff Order of True-up for FY 2019-20, APR of FY 2020-21 and ARR for FY2021-22;
- Review Petition has been uploaded on the website of BSPTCL. General public and stakeholders are requested to submit comments / suggestions / objections, if any to "Secretary, Bihar Electricity Regulatory Commission, Ground Floor, Vidyut Bhawan-II, Bailey Road, Patna – 800021" before 08.10.2021 by 5.00 PM.
- 4. The Bihar Electricity Regulatory Commission shall hear this matter on **22.10.2021** at **11.30 AM.** in its Court Room.
