1. <u>SCOPE :</u>

All properties situated anywhere in Bihar under the ownership of Bihar State Power Transmission Company Limited (BSPTCL) viz. Company Office buildings, residential colonies, stores, entire line & cables, PSS/GSS/Other installations, etc. shall be included for insurance coverage. 2. SUBMISSION OF TENDER DOCUMENTS:

The tenderer should also mention the name of the Agency/ Firm/ Company/ State Government/ Central Government/ State & Central Govt. Undertakings with address, telephone no., Mobile no., Fax no., NIT No., applied for, due date of opening of the tender and details of the Earnest Money deposited on the cover of both the sealed envelopes. Tender received in unsealed/ open envelopes will be rejected. The tenderer should also submit ANNEXURE "C" along with other documents.

3. COST OF BOQ:

4. VALIDITY OF TENDER:

The offer of the tender should be valid for at least 90 days from the date of opening of the Part-I i.e. Technical and Commercial Part.

5. <u>EARNEST MONEY:</u>

(a) Tender must be accompanied with non interest bearing Earnest Money of Rs. 50,000/- (Rupees fifty thousand only) failing which tender will not be considered for opening of the Price Part.

(b) The Earnest Money should be deposited either in cash with Accounts officer, Bihar State Power Transmission Company Limited, Patna and reference of Money Receipt no. and date to be mentioned in the tender or in form of Bank Draft issued by a Nationalised Bank/Scheduled Bank only, drawn in favour of, Bihar State Power Transmission Company Limited, payable at Patna.

(c) Cheques will not be accepted.

(d) No Earnest Money will be accepted after the due date and time of submission of tender document.

(e) Earnest Money deposited with other NIT will not be adjustable with this NIT.

(f) No Bank commission or interest will be paid on the Earnest Money.

6. EXEMPTION FROM DEPOSITING OF EARNEST MONEY:

State Government, Government of India and State Govt. & Central Govt. Undertakings are exempted from deposit of Earnest Money.

7. FORFEITURE OF EARNEST MONEY:

(a) If a tenderer withdraws its offer after opening of Technical & Commercial Part (Part-I) or Price Part (Part-II) before validity period of the tender, the earnest money deposited by them will be forfeited.

(b) If a successful tenderer fails to deposit requisite amount towards the Performance Security within specified time as per intimation/ request of company.

(c) If a successful tenderer fails to execute an Agreement within specified time as per intimation/request of the company.

8. <u>PERFORMANCE SECURITY:</u>

The successful tenderer will deposit Rs. 2,50,000/- (Rupees two lacs and fifty thousand) as Performance Security which is non interest bearing either in cash or in form of Bank Draft issued by a Nationalised Bank/Scheduled Bank only drawn in favour of Bihar State Power Transmission Company Limited, payable at Patna or in the shape of Bank Guarantee of Nationalised Bank/ Scheduled Bank only in favour of Accounts Officer, Bihar State Power Transmission Company Limited.

<u>Note:-</u> State Government, Government of India and State Govt. & Central Govt. Undertakings are exempted from deposit of Earnest Money.

9. <u>REFUND OF EARNEST MONEY AND PERFORMANCE SECURITY:</u>

Earnest Money deposited by the unsuccessful tenderer will be refunded to the tenderer immediately after finalisation of the tender. Earnest Money will be refunded to the successful tenderer on receipt of Performance Security. Further, the Performance Security will be refunded/ returned to the successful tenderer after successful completion of the Contract Agreement and settlement of accounts within six (6) months of completion of contractual period.

10. FORFEITURE/ ENCASHMENT OF PERFORMANCE SECURITY:

The Performance Security will be forfeited/ encashed in case of unsatisfactory performance of the successful tenderer. The decision of the BSPTCL shall be final and binding on successful tenderer.

11. ELIGIBILITY CRITERIA:

(i) The tenderers should be a Company registered under the Company Act 1956.

(ii) The tenderers, other than the Govt. owned Insurance Company should have to submit latest necessary documents in support of their entry into Insurance Sector, which they possess from Insurance Regulatory Development Authority of India.

(iii) The tenderers should have registration with Service Tax Authority.

(iv)The tenderers should have experience of Public Utility related insurance works.

(v)The tenderers will have to indicate the time they require for settlement and payment of claim(s).

12. FINANCIAL CAPABILITIES:

The tenderer should have a Minimum Average Annual Turnover of Rs. 100.00 crore (Rs. one hundred crore) for best 3 (three) Financial Years out of 5 (five) years.

13. <u>SETTLEMENT/PAYMENT OF CLAIM</u> :

The tenderers will have to indicate the time they require for settlement and payment of claim(s).

14. **DEPUTATION OF SURVEYERS** :

To facilitate early survey/assessment of the loss/damage in case of any claim, the tenderers will have to depute the surveyor at the site of loss/damage within 72 hours from the time of intimation by the Claim Officer of BSPTCL about the claim.

15. <u>RATES</u>:

The Tenderer must quote rates in figures and words in the prescribed format (ANNEXURE-"B") along with (ANNEXURE-"D") and in case of any discrepancy rates quoted in word will prevail.

16. EVALUATION OF PART-II i.e. PRICE PART:

The Part-II i.e. Price Part will be evaluated on the basis of the rates offered by the tenderers for all the assets and properties and accordingly the L-1 rate will be ascertained.

17. ALLOTMENT OF THE WORK:

The successful L-1 tenderer shall be allotted the work.

18. CONTRACT PERIOD:

The Contract Period will be for 1 (one) year. However, the same shall be extended after reviewing of the performance. The BSPTCL will have the authority to terminate the contract of successful tenderer and allot the same to any other willing valid tenderer in case of unsatisfactory performance of the successful tenderer and the Performance Security will also be forfeited. Further, contract shall be prematurely terminated in case of change in system.

19. AGREEMENT:

The successful tenderer will have to execute an Agreement with the Dy. General Manager (Finance) after depositing the amount/submission of B.G. against Performance Security within 15 days of the issuance of LOA. However the risk of the assets and properties of the BSPTCL will be covered from the date of the LOA.

20. <u>EXECUTION OF THE WORKS NOT COVERED IN THE</u> <u>AGREEMENT:</u>

Any other work not covered under this scope of tender document may be assigned to successful tenderer with mutually agreed terms & condition.

21. <u>BLACK LISTED FROM ANY SEBS/ POWER SECTOR/ STATE</u> <u>GOVT./CENTRAL GOVT/ STATE AND CENTRAL GOVT.</u> <u>UNDERTAKINGS AND CONVICTED BY COURT OF LAW:</u>

Tender submitted by any Agency/ Firm/ Company/ State Govt/ Central Govt./ State and Central Govt. Undertakings who had been blacklisted by any State Electricity Board/ Power Sector Company/ State Government/Central Government/ State and Central Undertakings and/or convicted by a Court of law will be rejected. An affidavit to this effect that they were not blacklisted and convicted by any Court of Law has to be submitted.

22. <u>AUTHENCITY OF THE DOCUMENTS:</u>

Every page of tender document along with enclosure must be signed by the tenderer.

23. JURISDICTION OF THE COURT:

In case of any legal dispute arising out of this tender/ contract, the jurisdiction shall be the Courts at Patna only.

24. <u>BASIS OF INDEMNITY</u> :

Basis of indemnification would be based on Reinstatement or Replacement of the property lost or damaged.

In cases where damage to an insured item can be repaired the insurer shall pay expenses necessarily incurred to restore damaged machine to its former state of serviceability plus the cost of dismantling and re-erection incurred for the purpose of effecting the repairs as well as ordinary freight to and from a repair shop, customs duties and dues, if any. If the repairs are executed at a workshop owned by the insured, the Insurer shall pay the cost of materials and wages incurred for the purpose of repairs plus a reasonable percentage to cover overhead charges. No deduction shall be made for depreciation in respect of parts replaced, but the value of any salvage shall be taken into account. If the cost of repairs as detailed herein above equals or exceeds the actual value of the machinery insured immediately before the occurrence of the damage, the item shall be regarded as destroyed and settlement shall be made on the basis provided for in

25. <u>CHECK LIST</u> :

28. <u>GENERAL:</u>
