REQUEST FOR COMMENTS / SUGGESTIONS / OBJECTIONS FROM GENERAL PUBLIC AND STAKEHOLDERS IN RESPECT OF

Petition for determination of Annual Revenue Requirement (ARR) and SLDC operating charges for FY 2018-19 for Bihar State Load Despatch Centre filed by Chief Engineer (System Operations), Bihar State Power Transmission Company Limited (BSPTCL) before the Hon'ble Bihar Electricity Regulatory Commission (BERC)

1. Notice is hereby given to all consumers and stakeholders and general public that the Bihar State Power Transmission Company Limited has filed the petition on 15.11.2017 for Review of ARR for FY 2017-18 and determination of ARR and SLDC operating charges for FY 2018-19 for Bihar State Load Despatch Centre before the Hon'ble Bihar Electricity Regulatory Commission under Bihar State Electricity Regulatory Commission (Levy and Collection of Charges by SLDC) Regulations, 2006 along with the other guidelines and directives issued by the BERC from time to time under sections 32, and 86 of the Electricity Act 2003 read with the relevant guidelines.
2. The filing of petition has been taken on record by the Hon'ble Commission in Case No.38 of 2017.
3. The Petitioner in his petition filed on 15.11.2017 has projected ARR for FY 2018-19 for Rs. 9.08 Crore. On queries and clarifications sought by the Commission for the projection of O&M expenses, the Petitioner has submitted the revised projected ARR for FY 2017-18 (RE) and for FY 2018-19 vide their letter No. 299 dated 15-12-2017 as detailed in Table below:

4. The Petitioner has proposed to recover ARR for FY 2018-19 on monthly basis from the Distribution companies viz. NBPDC & SBPDCL in their power sharing ratio.

6. Interested persons may inspect and peruse the said petition and additional information for the determination of revised ARR for FY 2017-18 and ARR and Operating charges of SLDC for FY 2018-19. The tariff petition alongwith additional information are also available at website of the Bihar State Power Transmission Company Limited www.bsptcl.in and can be downloaded there from.
7. Objections / Suggestion, if any, on the above said petition along with supporting materials may be filed with the **Secretary, Bihar Electricity Regulatory Commission, Ground Floor, Vidyut Bhawan-II, Bailey Road, Patna – 800021** in person or through registered post so as to reach him on or before **29.01.2018**.
A copy of the same shall be served on to the **Chief Engineer (System Operations), Bihar State Power Transmission Company Limited, 4th Floor, Vidyut Bhawan-I, Jawaharlal Nehru Marg, Patna – 800021** and proof of serving the same must be enclosed with the filing made to the Secretary, Bihar Electricity Regulatory Commission.
8. The objections / suggestions sought as above should be filed in six copies and carry full name and postal address of the person sending the objections. If the objection is filed on behalf of any organization or any class of consumers, it should be so mentioned.
9. The Bihar Electricity Regulatory Commission shall conduct public hearings on **22.02.2018 at 11:00 A.M.** in its Court Room.
