## REQUEST FOR COMMENTS/ SUGGESTIONS/OBJECTIONS

- 1. Bihar State Power Transmission Company Limited (BSPTCL), a transmission licensee in the state of Bihar, hereby gives notice to all the stakeholders and general public that it has filed petition(Tariff Petition) for approving Business Plan for the control period (FY 2025-26 to FY 2027-28) and for True-up of FY 2023-24, Annual Performance Review (APR) for FY2024-25 and determination of Multi Year Aggregate Revenue Requirement (ARR) for FY 2025-26 to FY 2027-28 and also for determination of Transmission charges for FY2025-26, before the Hon'ble Bihar Electricity Regulatory Commission under applicable Multi Year Transmission Tariff and SLDC Charges Regulations. The petition has been admitted by the Hon'ble Commission as Case No.27 of 2024.

Proof of aforesaid service must be enclosed with the filing made to the Secretary, Bihar Electricity Regulatory Commission.
- 5. The Comments/Suggestions/Objections shall be filed in six copies and shall carry full name and postal address of the person concerned. If the comments / suggestions/ objections is filed on behalf of any organization or any class of consumers, it should be so mentioned.
- 6. The Hon'ble Bihar Electricity Regulatory Commission has also communicated that it will conduct public hearing in this case on 19.02.2025 at 11:30 A.M in its Court Room at Patna.
