**I. COMPANY PROFILE**

NHPC Limited was incorporated on 7th November, 1975 under the Indian Companies Act, 1956 with the objective to be a global leading organization for sustainable development of clean power through competent responsible and innovative values. NHPC Limited is a Mini-Ratna Category-I PSE in Power Sector with the administrative jurisdiction of Ministry of Power.

The company employed 6753 regular employees( Executive 3533, Non-executive 3220) as on 31.03.2019.

Its Registered and Corporate offices are at Faridabad, Haryana.

The authorized and paid up capital of the Company was Rs.15, 000.00 crore and Rs.10, 045.03 crore respectively as on March 31, 2019.

The shareholding of the Government of India in the company is 73.33%.

**II. JOB DESCRIPTION AND RESPONSIBILITIES**

Director (Projects) is a member of Board of Directors and reports to the Chairman and Managing Director. He/She is overall responsible for project planning, execution and contracting. He/She assists CMD to ensure proper administrative and technical control of the projects and their timely execution.

**III. ELIGIBILITY**

1 . AGE : On the date of occurrence of vacancy (DOV)

**3. For candidates from SPSE/ Private Sector**

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

**2. EMPLOYMENT STATUS:**

**3. QUALIFICATION:**

The applicant should be an Engineering graduate preferably in Civil/Mechanical/Electrical Engineering from a recognized University/ Institute with good academic record.

**4. EXPERIENCE:**

The applicant should have adequate experience at a senior level in a large organization of repute, out of which at least five years cumulative experience during the last ten years should have been in project planning/design/execution/management.
