Whereas, the debarment of M/s Gepdec Infratech Limited & Siemens Limited Consortium was provisionally withdrawn vide this office order dated 23.06.2025, subject to the condition that the firm shall complete all balance civil works related to construction of (2x500 MVA + 2x160 MVA) 400/220/132 KV GIS Substation at Bakhtiyarpur by **15.07.2025**, as per their undertaking.

However, upon physical verification and review of site progress as on 15.07.2025, it has been observed that the firm has failed to fulfill its commitment regarding completion of all civil works despite repeated assurances and extended timelines.

In view of this, and in accordance with the terms and conditions of the NIT and the contractual obligations, M/s Gepdec Infratech Limited & Siemens Limited Consortium is **hereby debarred from participating in all future tenders of BSPTCL** until satisfactory completion of all left over work as per scope under NIT No. 15/PR/BSPTCL/2019.

This debarment is imposed with immediate effect and shall remain in force until further orders.
