In view of the above facts, all the Suppliers/Contractors of BSPTCL are hereby informed to submit their claims year wise for Form "C" to be issued against SUVIDHA generated to them latest by 15th October, 2017 along with the details of invoices for supply made by them failing which their claim for Form "C" shall not be entertained by BSPTCL and the failing agency shall have to bear the liability on account of this.
