Sub:- Regarding participation in the meeting regarding Lease of Dark Fiber on OPGW network of BSPTCL.

Sir.

BSPTCL has an extensive Optical Ground Wire (OPGW) of approx. 7,500 KMs in length in its 220 KV & 132 KV Transmission Line network spreading across Bihar having 12/24 fibre pairs in each cable. BSPTCL has obtained IP1 (Infrastructure Provider) certification from Department of Telecommunication, Govt. of India, which enables to lease spare unallocated dark fiber to authorized Telecom service Providers / Internet Service Providers (TSPs/ISPs). BSPTCL has successfully leased out approx. 6,300 fiber pair KMs of dark fiber to different Telecom Service providers / Internet service providers vide NIT No. 35/PR/BSPTCL/2022.

Further, BSPTCL intends to lease out maximum 08 pairs (Sixteen fibers) of unallocated Dark Fiber to different TSPs/ISPs in different routes through open tender. In order to obtain valuable suggestions / inputs of different TSP/ISPs regarding leasing of dark fiber, a meeting is scheduled in the office of Chief Engineer (Telecom & OPGW), BSPTCL, 4th floor, Vidyut Bhawan, Jawahar Lal Nehru Marg, Patna - 800 001 on dated 29/07/2025 at 11.30 Hrs.
