- a. BSPTCL respectfully submits that the Hon'ble Commission, in the Tariff Order dated 28.03.2025, directed BSPTCL to obtain prior approval for the list of 42 projects as specified in Annexure-A of the said Tariff Order. The present project was included in the said list of 42 projects and, in compliance with the directions of the Hon'ble Commission, BSPTCL accordingly included the project for approval as part of Case No. 38/2025, and subsequently included the same in the substitute Petition filed on 17th November 2025 for the said case.

 The project is duly reflected at Sl. No. 7 (Page No. 12) under Section 2.2, "Details of Schemes Already Approved by the Commission Proposed for Capitalization During FY 2025-26 to FY 2027-28", of the substitute Petition (Case No. 38/2025) filed on 17th November 2025. Hence,
- b. BSPTCL respectfully submits that the delay in completion of the subject project beyond the originally approved timeline of FY 2022-23 occurred due to several unavoidable circumstances and force majeure conditions.

BSPTCL is not submitting the required information again, as the same has already been

submitted and is presently under the consideration of the Hon'ble Commission.

At the initial stage of execution, the project suffered delays on account of the 2019 Lok Sabha Elections, during which movement of materials and transportation of tower stubs from the contractor's manufacturing units were severely restricted. Further, although the Go-Ahead for commencement of works was issued in July 2019, finalization of land for the Bakhtiyarpur New Substation was completed only in October 2019, resulting in a delay in commencement of associated transmission works.

Subsequently, execution of foundation works was adversely impacted due to severe water-logging conditions during September-October 2019, particularly in stretches located near the river Ganges, necessitating suspension of foundation activities for a considerable period. In addition, the project encountered critical Right-of-Way (RoW) issues at multiple locations, requiring prolonged negotiations with landowners, administrative intervention, and police protection, which significantly affected the pace of construction.

The progress of works was further disrupted due to restrictions on deployment of labour from other districts and states, followed by prolonged interruptions during the COVID-19 pandemic and nationwide lockdowns (March–June 2020), which resulted in complete shutdown of works, demobilization of migrant labour, and loss of an entire working season.

Thereafter, execution was also affected during the Bihar State Legislative Elections in October-November 2020, owing to restrictions on movement of men and materials.

Further, during 2024, the project was adversely affected by multiple incidents of theft of conductors and tower parts, necessitating re-stringing and rectification of damaged sections, thereby further delaying commissioning.

BSPTCL respectfully submits that despite the above constraints, all physical works under the project have since been completed and the transmission lines have been commissioned in a phased manner upon availability of shutdowns and readiness of downstream substations. The delay in completion beyond FY 2022-23 is thus attributable solely to genuine, unavoidable, and force majeure circumstances and not due to any lapse or inaction on the part of BSPTCL.

ii. BSPTCL respectfully submits that the said project "(i) Construction of (2x160MVA+3x50 MVA), 220/132/33KV GSS, Tajpur (Dist.- Samastipur) with SAS including Residential Quarters under turnkey basis. (ii)Construction of (2x160MVA+3x50 MVA), 220/132/33KV GSS, Thakurganj (Dist.- Kishanganj) with SAS including Residential Quarters NIT No.- 49/PR/BSPTCL/2022" has already been submitted for prior approval as part of Case No. 38/2025. The project is duly reflected at Sl. No. 7 (Page No. 24) under Section 2.2 "Details of remaining Projects Proposed for Capitalization During FY 2025-26 to FY 2027-28" of the substitute Petition (Case No. 38/2025) filed on 17th November 2025. In view of the above, BSPTCL most humbly prays that the Hon'ble Commission may kindly accord its approval to the said project.
