In continuation to this office order no 326 dated 06.05.2019 and Employment Notice No-08/2018 of BSP(H)CL, following candidates; who have been offered appointment and have also cleared Bio-metric / Aadhar verification held at BSP(H)CL headquarters; are provisionally appointed to the post of Technician -II and Technician- III on probation of two years from the date of issuance of Provisional Trade Certificate as mentioned against their names. As stipulated in their offer of appointment, during First Year of probation they shall be paid a consolidated sum of Rs 9200/- per month only, in consolidated pay band of Rs. 9200-15500/-. After successful completion of One Year of probation, i.e. from the date of issuance of Provisional Trade Certificate as mentioned against their names as Technician -II and Technician- III, they shall be allowed Regular Scale of Pay in the Pay level-4 & level-3 (as per 7th PRC) respectively plus other allowances as admissible as per Terms and Conditions stipulated in the Employment Notice and in their Offer of Appointment.
